

ADVERTISEMENT FOR BIDS

Sealed bids addressed to the City Manager of the City of Seguin, Texas will be received at the Seguin City Hall, 205 North River, Seguin, Texas 78155, until **2:30 P.M., February 2, 2016 (CDST)** for the **South River Street Improvements**. Any bid received after closing time will be returned unopened. The bids will be publicly opened and read aloud at the Seguin City Hall at 3:00 p.m. Bids shall be submitted in a sealed envelope (8-1/2" x 11" minimum), clearly marked as follows:

To be opened at 3:00 P.M., Tuesday February 2, 2016

Principal items of construction will include:

Installation of approximately 1,000 LF of 8" water line between Washington Street and Shelby Street, installation of 335 LF of 12" sanitary sewer line with all appurtenances between Shelby Street and E. Klein Street, installation of 750 LF of storm sewer between Shelby Street and E. Klein Street, installation of 500 LF of storm sewer down E. Klein Street with an outfall, microsurfacing S. River Street between Washington Street and Shelby Street, and mill and overlay on S. River Street between Shelby Street and E. Klein Street.

Each bid must be accompanied by a certified or cashier's check, or an approved bidders bond in an amount not less than 5% of the maximum total bid, payable to the City of Seguin, Texas without recourse, as a guarantee that the Bidder will enter into a contract and execute performance and payment bonds on the forms provided, within ten (10) days after the award of contract.

The successful Bidder must furnish Performance and Payments Bonds each in the amount of 100% of the contract price from an approved Surety Company holding a permit from the State of Texas to act as Surety and acceptable according to the latest list of companies holding certificates of authority from the Secretary of Treasury of the United States, or other Surety or Sureties acceptable to the Owner.

Plans and specifications may be examined without charge at Seguin City Hall. Bid Documents and Construction Drawings for the project may be viewed and downloaded free of charge (with the option to purchase hard copies) at www.civcastusa.com. Bidders must register on this website in order to view and/or download specifications, plans and other related documents for this project. It is the responsibility of the Contractor bidding to use proper scaling, paper size, etc., for bid quantities. Failure to do so may result in error in the Unit Bid Quantities and/or Bid Amounts.

The City of Seguin reserves the right to reject any or all bids and to waive informalities. No bid may be withdrawn within ninety (90) days after the date on which bids are received.
