

ADVERTISEMENT FOR BIDS

Sealed bids addressed to the City Manager of the City of Seguin, Texas will be received at the Seguin City Hall, 205 North River, Seguin, Texas 78155, until **2:30 P.M., May 17, 2016 (CDST)** for the **Sagebiel Road 15” Sanitary Sewer & Schaffer Road 8” Sanitary Sewer**. Any bid received after closing time will be returned unopened. The bids will be publicly opened and read aloud at the Seguin City Hall at 3:00 p.m. Bids shall be submitted in a sealed envelope (8-1/2” x 11” minimum), clearly marked as follows:

Principal items of construction will include:

Installing approximately 1,200 L.F. of 8” gravity sewer with four (4) manholes located west of State Highway (SH) 46, between C.H. Matthies Jr. Drive and Best Drive and with all other necessary appurtenances for Schaffer Road.

Remove and replace four (4) manholes and approximately 790 L.F. of existing 10” gravity sewer main with 15” gravity sewer main, extending from a Tributary to Geronimo Creek to Sagebiel Road and installing eight (8) manholes and approximately 3,100 L.F. of 15” gravity sewer along Sagebiel Road to FM 466, and with all other necessary appurtenances for Sagebiel Road.

Each bid must be accompanied by a certified or cashier's check, or an approved bidders bond in an amount not less than 5% of the maximum total proposal, payable to the City of Seguin, Texas without recourse, as a guarantee that the Proposer will enter into a contract and execute performance and payment bonds on the forms provided, within ten (10) days after the award of contract.

The successful Bidder must furnish Performance and Payments Bonds each in the amount of 100% of the contract price from an approved Surety Company holding a permit from the State of Texas to act as Surety and acceptable according to the latest list of companies holding certificates of authority from the Secretary of Treasury of the United States, or other Surety or Sureties acceptable to the Owner.

Plans and specifications may be examined without charge at Seguin City Hall. Bid Documents and Construction Drawings for the project may be viewed and downloaded free of charge (with the option to purchase hard copies) at www.civcastusa.com. Bidders must register on this website in order to view and/or download specifications, plans and other related documents for this project. Failure to do so may result in error in the Unit Bid Quantities and/or Proposal Amounts.
