2. Reference the specifications, Table of Contents: delete "Proposal 2 Bid – Cushman Breaker Additions Project"; delete "Proposal 2 Bid Form"; delete "Totals Summary Sheet for Proposal 2 Bid"; and delete "Project Specifications for Proposal 2 Bid".
3. Reference the specifications, Project Schedule: delete all references to Proposal 2 from the Project Schedule.
4. Reference the specifications, Advertisement for Bids, fourth paragraph: this paragraph is hereby deleted in its entirety.
5. Reference the specifications, Special Instructions, page 00400. Paragraph 1.7 is hereby deleted in its entirety.
6. Reference the specifications, Special Instructions, page 00400. Paragraph 2 is hereby deleted in its entirety and replaced by the following:

2. PROPOSALS AND METHOD OF BIDDING

- 2.1 The proposal consists of various major items of work. Bidders will provide prices for each item in the proposal. The prices will be entered in the appropriate spaces in both script and figures. Should the Bidder have costs for any incidental work where a bid item does not occur, the costs of such work will be reflected in the unit costs of the bid items in the proposal. No

separate payment will be made for any work other than those items occurring in the proposals.

2.2 Bidders shall bid on all items in the proposal.

6. Reference the specifications, Special Instructions, page 00402: paragraph 13.1 is hereby deleted in its entirety and replaced by the following:


13.1 An award will be made to only one Contractor. The award may be made for the lowest base bid or the lowest base bid including alternate bid items(s), if applicable.
