## PROJECT UPDATE

### SATURDAY, MAY 17TH

**\*\*WORK SCHEDULED \*\***

Dirt crew will be working along Martindale Road and grading behind the curb.

### WEEK OF MAY 19th - MAY 24th

Dirt crew will continue working and cleaning along Martindale Road.

A small grading crew will also continue working behind the curbs, and shaping and spreading the soil in preparation for sod placement.

Miscellaneous cleanup will also be taking place.

A small utility crew will begin raising manhole and water valve covers. This process consists of cutting the street asphalt around the manhole and raising the manhole cover to become level with the top of the street asphalt. A concrete diamond will then be placed around the cover to secure it in place. Work will start in the back of the subdivision.
