Seguin Events Complex *RV Rules and Regulations*

1. Your check in time will be arranged upon confirmation of your reservation.
2. No refunds will be given for early departures.
3. Guests are responsible for the actions of their visitors.
4. Quiet hours are from 10:00 p.m. to 6:00 a.m.
5. All trash must be disposed of in the dumpster located onsite.
6. No swimming pools are to be set up on City property.
7. Rowdiness, loud music, abrasive language, weapons, fighting, lewd conduct, reckless driving/speeding, drunkenness, and possession or use of drugs will not be tolerated at any time.
8. No fireworks or explosives are permitted within any RV or on the person of any guest.
9. Selling, advertising, or distribution of any product (including alcohol) is prohibited unless a permit has been issued.
10. Parents are responsible for the conduct of their children and financially responsible for any damages incurred by their children. Children under the age of 13 must be accompanied by an adult at all times while on City property.
11. The City of Seguin is not responsible for damages to RV's or vehicles, theft, or injuries during your stay.
12. The City of Seguin will not be responsible for theft or injury occurring during your stay.
13. Littering and glass on the property is prohibited.
14. The City of Seguin is in no way liable for any loss or damage by fire, wind, theft, accident, or Acts of God.
15. Registered guests and visitors are liable for all property damages, including risks associated to their person, property, animals, and vehicles.
16. All federal, state, and local laws must be obeyed at all times.
17. Emergencies call 911. For conditions requiring staff attention, call 830-433-1431.
18. No RV dump station is available onsite. All waste must be disposed of offsite.
19. The City of Seguin reserves the right to make changes without notice deemed necessary to these regulations. We reserve the right to refuse service to current or returning guests who have violated our Rules and Regulations and/or have vacated the Seguin Events Complex without paying all fees.

Parking and Vehicles

1. One (1) vehicle permitted per site plus your one (1) RV.
2. All vehicles must have current registration, inspection, and license plates.
3. RV should be parked no closer than 6 feet from the building and or fence no closer than 6 feet from other RVs.
4. No vehicle repairs, maintenance activities, fluid changes, washing/rinsing of vehicles/RV's are permitted on site.
5. No boats, flatbed trailers, or ATVs allowed.
6. Vehicles are not permitted to protrude from RV site into the flow of traffic.
7. Parking and/or hooking up in vacant RV sites will result in being charged the daily rate of the additional site and/or vehicle being towed at owner's expense.
8. Visitors or guests must park in the general parking area and are prohibited from parking in other RV sites.

Rig and/or Site Appearance

1. Open flames or non-contained fires for cooking or heating are not permitted. Small personal BBQ grills are allowed, but must be contained and enclosed.
2. Outdoor items such as furniture, etc. must be neat and orderly.
3. Keep all cords, cables, and hoses coiled and bundled.
4. Rope, wire, or string may not be attached and strung from vegetation, park property, or poles at any time.

Pet Rules

1. All pets must be on a leash (max: 10 ft) in owner's hand at all times while on the property.
2. Tying pets to fencing, vehicles, etc. is strictly prohibited.
3. Pets must be cleaned up after while on the property. Failure to do so may result in eviction.
4. Pets are prohibited in restrooms and event facilities.
5. Pets left alone must be secured in a kennel or dog pen to ensure the pet is not a threat to fellow guests or other pets.
6. Pets must not dig holes or otherwise create an unsightly appearance or damage to City property.
7. Constant or frequent barking of pets is prohibited.
8. Visitors with aggressive pets will be banned from the park.
